# Mobile health services offered at 14 sites in the county during April New location – Janie's Garden Apartments Special Event – Veterans 'Stand Down'

SARASOTA COUNTY — The Florida Department of Health in Sarasota County's (DOH-Sarasota) Health In Motion Mobile Medical Unit staff will provide

free and low-cost health services at 14 sites around the county during April. This includes a new regularly scheduled site - Janie's Garden Apartments, a Sarasota Housing Authority property located at 2446 Central Ave. in Sarasota. Once-a-month visits will begin on Tuesday, April 22, noon-4 p.m.

The mobile medical unit staff will also be present at the Veterans 'Stand Down' Event on Saturday, April 26, 8 a.m.-1 p.m. at the William L. Little Health and Human Services Center, 2200 Ringling Blvd. in Sarasota.



The services offered include diabetes education and screening, blood pressure tests, pregnancy testing, HIV testing, body mass index (BMI) measurement, adult immunizations and health education; however, not all services, including immunizations, are offered at all sites.

The staff also assists individuals who lack medical insurance and do not have a health care provider to find a medical home for ongoing health care.

No appointment is needed. Some services are free, including HIV rapid testing with results in 20 minutes. Other services are provided on a sliding-fee scale based on income. A registered nurse is available at all sites.

While these services are most often provided in a 40-foot-long bus, there are times when services are provided inside the facilities visited.
