# Free or low-cost mobile health services offered in Sarasota County

The Sarasota County Health Department's Health In Motion Mobile Medical Unit will travel to 14 sites in Sarasota County during May to offer free H1N1 (swine) flu vaccines along with its other regular services. The mobile unit also will travel to the Arizona Multi-Services Center, 3900 N. Washington Boulevard in Sarasota on Monday, May 17, from 1-3 p.m.

In addition, the Health In Motion staff will begin providing childhood immunizations at the Grande Court Apartments, 5203 Greenwood Ave., North Port, on Wednesday, May 12. The June schedule will be announced later next month.

Regular services include diabetes education and screening, blood pressure tests, pregnancy testing, HIV and tuberculosis testing, adult immunizations and health education to those who lack medical insurance and do not have a health care provider. Assistance with finding a permanent health care provider also is available.

No appointments are needed. Some services are free, including HIV rapid testing with results in 20 minutes. Other services are offered on a sliding fee scale based on income. Licensed volunteer physicians from the Senior Friendship Centers provide basic medical care when the mobile medical unit is at the Salvation Army in Sarasota. A registered nurse is available at all sites.
