Mobile health services offered at 13 county sites in August

New Sarasota site added to schedule

SARASOTA — The Sarasota County Health Department's Health In Motion Mobile Medical Unit staff will provide free and low-cost health services at 13 sites around the county during August. The Walmart Neighborhood Market, 3500 North Tamiami Trail (U.S. 41), Sarasota, has been added to the regular schedule, starting in August. Services will be discontinued at the Sarasota Housing Authority property at N. Orange Ave. in Sarasota due to lack of participation by area residents.

The services offered at the established sites include diabetes education and screening, blood pressure tests, pregnancy testing, HIV testing, body mass index (BMI) measurement, adult immunizations* and health education. The staff also assists individuals who lack medical insurance and do not have a health care provider to find a medical home for ongoing health care.

No appointment is needed. Some services are free, including HIV rapid testing with results in 20 minutes. Other services are provided on a sliding-fee scale based on income. A registered nurse is available at all sites.

While these services are most often provided in a 40-foot-long bus, there are times when services are provided inside the facilities visited.

*Some services, including adult immunizations, are not offered at all locations.
